NOTIFICATION

An overall decline in the sex ratio especially in child sex ratio in 0-6 years has been reported in Himachai Pradesh between 1991 & 2001 and the situation is alarming in Kangra, Una, Bilaspur and Hamirpur Districts. Therefore, in order to counter the declining sex ratio, the Governor, Himachai Pradesh is pleased to notify the following schemes to achieve the desired results:-

1. Scheme for selection of Panchayat with best sex ratio and payment of Rs.5.00 Lacs as an additional development grant.

The norms shall be as follows:-

- 1) 12 Panchayats one in each district of the State shall be paid Rs.5.00 Lacs each per year as additional grant for achieving the best sex ration in 0-6 years.
- ii) The data supplied by Central Registration System of the Health Department shall from the base for selection of the best Panchayat.
- III) The data for the year 2004-05 shall form basis for selection of Panchayat having best sex ratio at birth for payment of Rs.5.00 Lacs additional development grant for 2006-07.
- Iv) For subsequent years the incremental increase in sex ration over the previous year shall form the basis for selection of the best Panchayat.

The grant shall be released through District Health Mission.

The scheme shall be implemented by the Block Development Officer.

vII)The selected Panchayat shall decide their own priorities for utilization of the grant.

- 2. Norms for award of Rs.10,000/- providing information about female foeticide under PNDT Act,1994.
- Any body who gives information in person or on telephone/fax/in writing to the appropriate authority of the District i.e. The CMO of the concerned district shall be deemed to be an informer.
- II) Identity of the informer shall not be disclosed
- III) The Incentive money I.e. Rs.10,000/- would be given in cash.
- Iv) The payment of cash award shall be subject to the nailing down of the culprit and to the satisfaction of the appropriate authority.
- 3. Scheme for implementation of "Indira Gandhi Salika Suraksha Yojna".

The norms shall be as follow:-

- I) Couples who adopt terminal family planning methods i.e. either Mini Lap. Tubectomy/Laproscopic Sterilization/Vasecotomy/IISV shall be eligible for incentive under the scheme provided the couple has one/two living female children and having no male issues.
- by the Medical Officer who performs the terminal family planning procedure on the eligible couple. One copy of the said form shall be handed over to the eligible couple and one shall be kept in the office of District Family Planning Officer for record.
- III) Rs.25,000/(Twenty Five Thousand only) shall be payable to those eligible couples having only one female child.
- Iv) Rs.20,000/-(Twenty Thousand only) shall be payable to those eligible couples having only two female children.
- v) The eligible couple shall have to submit an affidavit duly attested by an Executive Magistrate of the area stating therein that they have only one female child or two female children at the time of acceptance of permanent sterilization method. They shall also state that they have no male issues.
- vi) Only such eligible couple shall be entitled to claim incentive whose name is entered in the eligible couple register maintained by Health Workers/Health Supervisors.
- vii)The case shall be initiated by the Health Worker at the Sub Centre level, which shall then be verified by the Panchayat

- VIII)The Health Worker shall submit the case to the concerned BMO who after having satisfied himself about the genuineness of the case shall recommend and forward the case to the District Family Planning Officer.
- 14) The District Family Planning Officer shall put the case for the approval of the CMO, where-after the interest bearing deposit for the amount as indicated at Sr.No.III & Iv above shall be prepared in the name of the concerned female child and handed over to the parents. Such Interest bearing deposit can be ericashed after the girl having attained the marriageable age/at the time of marriage.


